**Photo ID**  
**Social Security Cards** (For you, your spouse, and any dependents)  
**Income Documents** (W-2 or 1099)  
**Last Year's Tax Return**  
**Bank Information:** (For direct deposit, bring your bank account and routing numbers)

**Childcare Expenses:** Documentation of childcare provider(s) and costs, if applicable.  
**Health Insurance Information:** Form 1095-A, 1095-B, or 1095-C, if applicable.  
**Any Additional Forms:** If you have specific tax situations (like self-employment income, rental property, etc.), bring relevant documentation.
